Chances are that 80% of the people reading this have never attended a precinct caucus. And, chances are you're saying to yourself, "Why should I bother?"

Caucuses are important. Here's why.

The Precinct Caucus is a traditional biennial meeting of the Republican and Democrat voters. You may have seen a lot in the news about the Iowa caucus. Only a few states still hold caucuses and Washington is one of those states that holds both a caucus and primary.

WHAT HAPPENS AT THE **CAUCUS?**

In most of Washington, voters from each precinct gather at separate locations. San Juan County, holds "pooled caucuses", with multiple precincts meeting at a designated location.

At the Caucus, attendees are asked to discuss and then fill out questionnaires about issues of most importance to them. The important part is that each of the caucus attendees has a chance to speak to the group about their preference as to who the presidential candidate for their party should party platform and choose the

After discussion, the group elects delegates to the county convention. The candidates to the county convention are usually elected based on their stated preference for a certain candidate.

Based on population, each precinct is allotted a certain number of delegates and alternates to the County Convention.

At the county convention, delegates are elected to attend the state convention, and the voting delegates develop the party platform for the biennium. The platform expresses the goals that the political party will work to achieve throughout the next two years.

WHY IS THE CAUCUS **IMPORTANT?**

In a state where there is no registration by political party, the caucuses serve as a way for Republicans and Democrats to identify party members. Voters must choose whether to attend the Democrat or Republican caucus and must sign a declaration of party affiliation in order to participate.

The caucus is also the place where neighbors can discuss political issues and candidates and get information. It's a place to use your powers of persuasion to convince others to vote for your choice of candidate.

In Washington State, voters choose the delegates to their county convention at the caucus. Those delegates to the county convention then vote on the county

delegates to the state convention. At the state convention, delegates are entrusted to vote on the state party platform and to choose the candidates to the national convention where the party candidate for the office of President will be decided

The caucus is truly the grassroots of politics and if you choose not to participate, you are missing out on one of the most direct and participative ways to be a part of the political process.

You should attend the caucus if you are interested in being a delegate to the county convention or if you want to have a say in who will be representing you at the convention and who your party candidate for President will be.

The people who represent us at the county and state convention will make a difference in what goes into the platform that represents our political views.

Republicans will hold their caucuses on Saturday March 3 at 10:00 AM.

All precincts will have pooled caucuses. Orcas 1. 2. Decatur. Blakely and Waldron are at the Orcas Island Firehall. 24 Lavender Lane, Eastsound.

Orcas 3.4 at the American Legion 793 Crescent Beach, Eastsound. Lopez 1,2 at Woodmen Hall on Lopez. Shaw caucus will be at the home of Levi Rawls.

All of San Juan Island Precincts and Stuart Precincts will be at the San Juan Island Grange on First Street in Friday Harbor.
